CONTRACT TERMS AND CONDITIONS

SECTION 1: The Shipper agrees that the Carrier shall not be responsible for the conduct or acts of the animals to themselves or to each other such as biting, kicking, goring or smothering, nor for loss or damage arising from the condition of the animals themselves, or which results from their nature or propensities, which risks are assumed by the Shipper. The Shipper hereby releases and discharges the Carrier from all liability or delay, injuries to or loss of said animals and paraphernalia from any cause whatsoever, unless such delay, injuries, or loss shall be caused by the Carrier or by the negligence of its agent or employees, and in such event the Carrier shall be liable only to the extent of actual damage sustained and in no event to an amount for an animal in excess of the value declared herein.

SECTION 2: The Shipper agrees to indemnify and save harmless the Carrier from all claims, liabilities and demands of every kind by reason of personal injuries or death sustained by such attendant, whether the same be caused by negligence or otherwise; this being in consideration of the free transportation of said attendants acting as the agents or employees, of the Shipper

SECTION 3: The above Terms and Conditions shall be binding upon the Carrier, the Shipper and the Consignee, and shall apply to any reconsignment or return of the shipment.
